1. Cash Incentive:

Paper Published in SCI/SCIE/Scopus/SJR/UGC listed journals, full length conference papers, Books and Patents qualify for the award incentive as per table-1 provided.

- 1.2. Authors can claim award incentives for a maximum of five papers in calendar year for paper published in S. No. 1.2 journals.
- 1.3. Authors can claim award incentives for a maximum of ten papers in calendar year for paper published in S. No. 1.3 journals.
- 1.4. Authors can claim award incentives for a maximum of fifteen papers in calendar year for paper published in category-D journals.

- 1.5. Author can claim award incentive for student paper/book/patent as a guide. The award incentive will be 50% of first author in given in table 1.
- # Category D is reserved for published in Journal with ISSN/DOI or five year old
- 2. Grants of Patents: If the Patent is in the name of the Institute, i.e. Bansal Institute of Engineering and Technology, Lucknow, total cost of filing the patent and paying the fees at different stages of the process will be reimbursed by the institute. He/She will be rewarded with Rs. 10,000/ for Design and Plant patents and 25,000/ for Utility patents.
- 3. If a faculty member granted Design or Plant patents of research work, in his/her name, total Rs. 10,000/- will be rewarded, which will be equally divided among all inventors and if it is Utility patents of research work, total Rs. 15,000/-will be rewarded which will be equally divided among all inventors.
- 4. A faculty member will be reimbursed 50% of the Annual Membership fee if he/she joins any professional body in respective domain of the faculty member.

5. Eligibility and Responsibility

- 5.1. Faculty members appointed on regular basis.
- 5.2. For Research Award Incentive only those paper/book/patent will be consider if name of affiliations, including address must be written Bansal Institute of Engineering and Technology Lucknow, NH-24, Near Sewa Hospital, Sitapur Road Lucknow, 226021.
- 5.3. In case of single author award incentive will be sum of first and second author given in table1.
- 5.4. For conference paper the amount of award incentive is similar as first author of table 1. If conference Venue distance is more than 100km, extra one thousand will be given in award incentive. For conference paper award incentive author must submit your presented certificate, proceeding with full length paper.
- 5.5. For NPTEL online Certificate Courses award incentive will be given if greater than 60% score in test exam.
- 5.6. The First Author/Corresponding author shall take the responsibility to screen the paper for plagiarism, ethics approval and background checks about the potential, possible, or probable predatory scholarly journals before communicating the research publication.
- 5.7. BIET shall reserve the rights to revise the incentive policy periodically.

6. Plagiarism and related issues:

In the event of any conflict about authorship related to scientific misconduct, a Committee shall be constituted by Research and Development under the direction of the college management to investigate the matter as per the policy adopted by BIET.

Authors can claim award incentives for a maximum of ten papers in calendar year for paper published in S. No. 1.3 journals.

Authors can claim award incentives for a maximum of fifteen papers in calendar year for paper published in category-D journals.

Author can claim award incentive for student paper/book/patent as a guide. The award incentive will be 50% of first author given in table 1.

Category D is reserved for published in Journal with ISSN/DOI or five year old journals.

3. Eligibility and Responsibility

Faculty members appointed on regular basis.

For Research Award Incentive only those paper/book/patent will be consider if name of affiliations, including address must be written as Bansal Institute of Engineering and Technology Lucknow, NH-24, Near Sewa Hospital, Sitapur Road Lucknow, 226021.

In case of single author award incentive will be sum of first and second author given in table1.

For conference paper the amount of award incentive is similar as first author of table 1. If conference Venue distance is more than 100km, extra one thousand will be given in award incentive. For conference paper award incentive author must submit certificate of presentation, proceeding with full length paper.

For NPTEL online Certificate Courses, award incentive will be given if faculty score more than 60% score in final result.

The First Author/Corresponding author shall take the responsibility to screen the paper for plagiarism, ethics approval and background checks about the potential, possible, or probable predatory scholarly journals before communicating the research publication.

BIET shall reserve the rights to revise the incentive policy periodically.

4. Plagiarism and related issues:

In the event of any conflict about authorship related to scientific misconduct, a Committee will be constituted by Research and Development under the direction of the institute management to investigate the matter as per the policy adopted by BIET.
